2/ उक्त आदेश के विरुद्ध माननीय छत्तीसगढ़ उच्च न्यायालय बिलासपुर में दायर याचिका क्रमांक WPS 1391/2024 एवं अन्य में पारित निर्णय दिनांक 15.3.2024 निम्नानुसार हैं :-

Learned Advocate General would submit that i view of the order dated 21-12-2023 & 23-02-2024 issued by the Election Commission of India, the petitioners who are presently working as Naib Tahsildar/Tahsildar/Chief Executive Officer/Assistant Superintendent (Land Record)/ Excise Officer/Excise Inspector, have been transferred who are neither appointed as Returning Officer (RO) nor Assistant Returning Officer (ARO) for upcoming election. This anomaly of issuance of transfer order has been rectified by Election Commission of India vide order dated 27-02-2024 clarifying that the earlier order issued by the Election Commission of India on 21-12-2023 & 23-02-2024 shall be applicable to the persons who are working as DEO, Dy. DEO, RO, ARO & Range ADG, IG, DIG, SSP, SP, Addl. SP, Dy.SP Circle officer (for equivalent rank police officers) only. Thus, the ground for transfer has already been clarified as such the foundation of the transfer orders has lost its significance in view of the subsequent order dated 27-02-2024 issued by the Election Commission of India.

Considering the fact that the foundation of the transfer orders in view of vide order dated 21-12-2023 & 23-02-2024, which has been clarified vide order dated 27-02-2024, the impugned transferred orders so far as relates to the petitioners who are presently working as Naib Tahsildar/Tahsildar/Chief Executive Officer/ Assistant Superintendent (land Record) Excise Officer/ Excise inspector, are quashed.

1. Since common facts & law are involved in these writ petitions, they are heard analogously and are being disposed of this common order.
2. The petitioners who are present working as Naib Tahsildar/ Tahsildar/Chief Executive Officer/Assistant Superintendent (Land Record)/Excise Officer/Excise Inspector, have been transferred in view of the order dated 21<sup>st</sup> December, 2023 issued by the Election Commission of India.
3. Learned Advocate General would submit that in view of the order dated 21.12.2023 & 23.02.2024 issued by the Election Commission of India, the petitioners who are presently working as Naib Tahsildar/ Tahsildar/ Chief Executive Officer/ Assistant Superintendent (Land Record)/Excise Officer/Excise Inspector, have been transferred who are neither appointed as Returning Officer (RO) nor Assistant Returning Officer (ARO) for upcoming election. This anomaly of issuance of transfer order has been

rectified by Election Commission of India vide order dated 27.02.2024 clarifying that the earlier order issued by the Election Commission of India on 21.12.2023 & 23.02.2024 shall be applicable to the persons who are working as DEO, Dy. DEO, RO, ARO & Range ADG, IG, DIG, SSP, SP, Addl.SP, Dy.SP, Circle Officer (for equivalent rank police officers) only. Thus, the ground for transfer has already been clarified as such the foundation of the transfer orders has lost its significance in view of the subsequent order dated 27.02.2024 issued by the Election Commission of India.

4. Considering the fact that the foundation of the transfer orders in view of vide order dated 21.12.2023 & 23.02.2024, which has been clarified vide order dated 27.02.2024, the impugned transferred orders so far as relates to the petitioners who are presently working as Naib Tahsildar/ Tahsildar/ Chief Executive Officer/ Assistant Superintendent (Land Record)/Excise Officer/ Excise Inspector, are quashed.
5. Consequently, the abovementioned writ petitions are allowed.
